AAVLD Innovation in Veterinary Diagnostic Medicine Grant Program Official Rules

Sponsored by Thermo Fisher Scientific

NO PURCHASE NECESSARY TO ENTER OR WIN

1. HOW TO APPLY:

To participate in the AAVLD Innovation in Veterinary Diagnostic Medicine Grant Program (the "Program"), you must submit your online Grant Proposal (the "Proposal") at <u>ikistler@aavld.org</u> and copy <u>rozuna@aavld.org</u>. All required information for the Proposal must be completed. Additionally, the submitter must review and accept these Program Official Rules. The Proposal must be received by AAVLD between March 20, 2018 and 11:59 p.m. US Eastern Time on June 30, 2018. By applying, you represent that you and your institution or employer are not prohibited by employment, law, regulation, industry code of conduct or the policies or practices of your institution or employer from participating. The Program is void wherever prohibited or where registration or bonding is required, and is subject to all applicable laws and applicable industry codes of conduct.

2. ELIGIBILITY:

The primary investigator ("PI") and all co-investigators must be American Association of Veterinary Laboratory Diagnosticians ("AAVLD") members located in the United States (excluding Puerto Rico) or Canada (excluding Quebec). Although an individual may be an investigator on more than one Proposal to this Program, an individual can serve as the PI on only one Proposal. For clarification, the same individual may be a PI on one Proposal and a co-investigator on another Proposal.

The person submitting the Proposal is the applicant ("Applicant") and is entering on behalf of their employer, which will be the recipient of the Award (each a "Grant Recipient"). Applicant warrants that they have obtained any necessary permission to submit a Proposal to this Program and authorization from their employer or responsible supervisor. Void where this promotion or acceptance of a grant is prohibited or restricted by law or subject to registration or other procedures that AAVLD and/or Thermo Fisher Scientific ("Thermo Fisher") may not have undertaken. Determination of eligibility is at the sole discretion of AAVLD and/or Thermo Fisher. Affiliates, subsidiaries, distributors and other sales intermediaries, advertising, promotion, and fulfillment agencies of Thermo Fisher, and immediate family members and employees, officers and directors of Thermo Fisher or those living in their same household, are not eligible to participate. Individuals entering on behalf of their institution/employer give permission on behalf of themselves and their institution to Thermo Fisher to contact them and their institution about Thermo Fisher's products and services, whether or not participant is selected to receive a grant.

Federal or state government employees (excluding state university employees) may not participate in this promotion.

3. OBJECTIVE OF PROGRAM:

The objective of this Program is to provide funding to individuals pursuing innovative ideas that advance veterinary diagnostic medicine. Through this Program, the Sponsor seeks to support innovation in research and development, help to define the next generation of scientific breakthroughs and reward and enable important research by providing funding to individuals pursuing innovative experiments.

4. GUIDELINES FOR PROPOSAL:

Proposals must be in the English language and must follow these guidelines:

Project Summary (200-300 word lay language summary of the project)

- 3. Experimental plan and expected results

Body of Proposal (maximum of 3 pages - single-spaced)

- 1. Brief literature review statement of the problem/hypothesis
- 2. Objectives
- 3. Plan of work -- approach, methodologies and timetable
- 4. Justification -- relevancy to diagnostic medicine and stated research priorities
- 5. Previous work of investigator(s) related to this proposal

References - up to one page, single-spaced

Biographical Sketch - one for each investigator, up to one page each

- 1. Name
- 2. Title

- 3. Education
- 4. Research & Professional experience most significant/recent publications

Current and Pending Support for each investigator related to this Proposal

- 1. Project title
- 2. Source
- 3. Amount requested/awarded

Budget (no indirect costs)

- 1. Maximum of one page
- 2. Include a brief budget justification narrative

5. CRITERIA FOR SELECTION OF THE GRANT RECIPIENTS:

Proposals will be reviewed by a committee of five AAVLD members with expertise in different areas of veterinary diagnostic medicine. Two representatives from Thermo Fisher Scientific with backgrounds in veterinary diagnostics will serve as non-voting review committee members. The committee will make the final decision on which proposals are funded based on the quality of the proposal and fit with stated research priorities for the year.

Priority will be given to proposals related to developing innovative new ideas for the use of current diagnostic assays (e.g., use of oral fluids in pigs for PCR and serology) or development of innovative new assays (e.g., metabolomics) for use in veterinary medicine. Criteria utilized in the evaluation process will include scores for innovativeness, potential for broad impact on veterinary diagnostic medicine, clarity of the proposal, quality of the science, and plan and likelihood that the work could be completed within one year of award of the grant.

Proposals will be judged on the following criteria:

1. Significance/Impact: Does this study address an important problem? If the aims of the Proposal are achieved, how will scientific knowledge be advanced? What will be the effect of these studies in the given field of veterinary diagnostics? (30%)

2. Science Approach/Content: Are the conceptual framework, design, methods, and analyses adequately developed, well integrated, well-reasoned, and scientifically sound appropriate to the aims of the project? (30%)

3. Innovation: Is the project original and innovative? For example, does the project challenge existing paradigms; address an innovative hypothesis or critical barrier to progress in the field? Does the project develop or employ novel concepts, approaches, methodologies, tools, or technologies for this area? (30%)

5. Feasibility: Is there a clear plan to complete the work within one year from award of the grant? (10%)

6. CANCELLATION:

There must be a minimum of three Proposals received to the Program to proceed to the judging stage. If a minimum of three Proposals are not received by June 20, 2018, the Program will be cancelled. Should the Program be cancelled, all entrants will be notified via email. Judges' decisions are final on all matters and shall not be subject to challenge or appeal. In addition, the Sponsor and AAVLD reserve the right, in their sole discretion, to cancel, terminate, modify, or suspend this Program should any virus, bug, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness, or proper conduct of the voting process. The Sponsor, AAVLD, their affiliates, partners and promotion and advertising agencies are not responsible for technical, hardware, software, telephone or other communications malfunctions, errors or failures of any kind, lost or unavailable network connections, the site internet, or ISP availability, unauthorized human intervention, traffic congestion, incomplete or inaccurate project information (regardless of cause) or failed, incomplete, garbled, jumbled or delayed computer transmissions which may limit one's ability to complete necessary steps to complete submission, including any injury or damage to participants or any other person's computer or mobile device relating to or resulting from participating in the voting or downloading any materials. 7. GRANT RECIPIENTS:

Two Grant Recipients will be selected by the panel of judges from all eligible Proposals received, based on the criteria set forth in Section 5 above.

8. NOTIFICATION and GRANT RECIPIENT'S OBLIGATIONS:

The Grant Recipients will be notified by email or mail of their selection as a winner on approximately September 15, 2018. Any notification returned as undeliverable may result in disgualification. The grant is not transferable; no substitutions are allowed except by Sponsor No responsibility or liability is assumed for damages, losses or injury resulting from acceptance or use of any grant. All other expenses and costs not expressly set forth herein are the Grant Recipient's sole responsibility. The winning Applicants and Grant Recipients will be required to execute and return an Affidavit of Eligibility/Release of Liability/Assignment of Rights/Publicity Release (where legal) and the Grant Recipients will be required to execute and return an Acceptance of Grant document. Each document must be signed and returned to the Sponsor and AAVLD within 15 days of notification .. If a winning Applicant and/or Grant Recipient fails to return these documents by the deadline, the grant will be forfeited and an alternate recipient may be determined, based on the criteria set forth above. TAXES, INCLUDING SALES, FEDERAL, STATE, AND LOCAL TAX, IF ANY, RELATED TO THE AWARD ARE THE RESPONSIBILITY OF THE GRANT RECIPIENT AND AAVLD WILL, IF APPLICABLE, ISSUE A 1099-MISC TO THE GRANT RECIPIENT. Each winning Grant Recipient will receive up to \$25,000 USD to be used to further their research. The check will be presented to the PI of the winning Grant Recipients during the AAVLD Annual Conference in Kansas City, MO in October of 2018. The PI of the Grant Recipient, a member of the Grant Recipient team, or their proxy must be present at the conference to claim their prize. The Grant Recipients will be responsible for their own accommodations and travel to the Conference; no travel assistance or accommodations will be provided.
