North Carolina Reveals First Look of New Agricultural Sciences Center

Ag Sciences Center shows its progress



The Agricultural Sciences
Center, of the North Carolina
Department of Agriculture and
Consumer Services, recently
revealed its first look to
stakeholders. According to
Director Jim Trybus the Center
is a unique facility in that it is
combining 5 aged agricultural
labs into a single facility
(veterinary diagnostic, food
and drug, structural pesticides,
standards lab, and motor

fuels). It will be the new home of the North Carolina Veterinary Diagnostic Laboratory Services and is located in Raleigh. The new 225,000 square foot building will expand capabilities with larger lab spaces and includes large animal and avian BSL-3 capable necropsy areas.

University of Nebraska Laboratory Initiates Human COVID Testing



The Nebraska Veterinary Diagnostic Center (VDC) is ramping up to test for SARS-CoV-2 for the University of Nebraska-Lincoln, reports Lab Director Bruce Broderson. The lab will be testing all students, faculty and staff before they return for the spring semester and continue throughout the semester. This

translates to 5,000 samples per day, to start, and then settling back to about 3,000 samples per day. The VDC will be using the SalivaDirect™ test.

Two AAVLD Members Recommended and Appointed to New AVMA Commission Advisory Group



AAVLD leaders endorsed and recommended, via a letter from President Zhang, two of our members to serve on the Advisory Group of the new AVMA/AAVMC Commission for a Diverse, Equitable and Inclusive Veterinary Profession. Recommended were Dr. Rafaela

De Negri (Breathitt Veterinary Center, Murray State University) and Dr. Keith Poulsen (WI Veterinary Diagnostic Laboratory, U of WI). We are pleased to inform you that both have been appointed to the Advisory Group. The selection committee was impressed with their credentials and background, as well as their stated commitment to advancing diversity, equity, and inclusion in the veterinary profession. The Advisory Group will play a crucial role in supporting the Commission's work and will be asked for critical feedback, environmental scanning, and occasionally take on specific projects.

The Commission will establish actionable outcomes for short-, medium- and long-term goals with defined timeframes. Initial goals for the commission will include:

Evaluation of a real-time RT-PCR panel for detection of SARS-CoV-2 in bat guano

Abstract. Severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) is the causative agent of coronavirus disease 2019 (COVID-19), which is an ongoing global health concern. The exact source of the virus has not been identified, but it is believed that this novel coronavirus originated in animals; bats in particular have been implicated as the primary reservoir of the virus. SARS-CoV-2 can also be transmitted from humans to other animals, including tigers, cats, and mink. Consequently, infected people who work directly with bats could transfer the virus to a wild North American bat, resulting in a new natural reservoir for the virus, and lead to new outbreaks of human disease. We evaluated a reverse-transcription real-time PCR panel for detection of SARS-CoV-2 in bat guano. We found the panel to be highly specific for SARS-CoV-2, and able to detect the virus in bat guano samples spiked with SARS-CoV-2 viral RNA. Our panel could be utilized by wildlife agencies to test bats in rehabilitation facilities prior to their release to the wild, minimizing the risk of spreading this virus to wild bat populations.




Figure. Alignment of the primers–probes and representatives of bat betacoronavirus group B

Bailey Reports from AVMA HOD Winter Session

The following 2 resolutions presented to the HOD for consideration were directly applicable to AAVLD:

AAVLD Liaison Report House Advisory Panel January 2021

1. Resolution #2 pertaining to reduced AVMA dues for recent veterinary graduates was

deferred to the AVMA Board of Directors for further review. The resolution generated a lot of discussion (approximately 90% of the overall discussion at this meeting) prior to and during the meeting. What I found most interesting is that strong sentiment was voiced by newer graduates and student chapter members that the resolution misses the mark. The reason given was that they would prefer to have resources committed towards AVMA programs, support and activities they can use, rather than have reduced annual dues. One such program commonly cited was additional mental health resources for newer graduates.

2. Resolution #8 pertaining to the use of ventilation shutdown for animal depopulation was not considered at this meeting since the sponsor did not submit the resolution by the prescribed deadline. However, it has potential to be an important issue at the AVMA Summer Meeting given its implications for the poultry and swine industries.

It was my honor to represent AAVLD at this meeting, and I greatly appreciate your trust in me.

Benefits of the AAVLD Accreditation Program

The American Association of Veterinary Laboratory Diagnosticians have been involved in laboratory accreditation since 1967 currently accrediting 63 laboratories in North America. The current AAVLD standard is closely aligned with ISO 17025, the international standard which is accepted by both the World Organization for Animal Health (OIE) and the Food and Agriculture Organization of the United nations (FAO) for veterinary diagnostic laboratories.

What is Laboratory Accreditation?

Accreditation is a voluntary, third party-reviewed process by a certifying body providing formal recognition of laboratory competence and quality. As part of accreditation, a laboratory's quality management system (QMS) is thoroughly evaluated on a basis to ensure continued management and technical competence and compliance with appropriate laboratory quality management system standards. The accreditation process is followed by ongoing maintenance of the QMS by the laboratory, as well as surveillance audits performed by a certifying body. The desired outcomes of this process are assurance of credible laboratory results for clients, and the expectation of continual improvement of the accredited laboratory's processes.

What are the Benefits of Accreditation?

AAVLD Accreditation does not certify a product or service, rather it attests that a laboratory adheres to documented processes and quality controls in conformance with ISO-based international standards. Conformance to standards inherently contributes to higher quality, safety, reliability, and consistency of services. This increases a laboratory's marketability, customer satisfaction, and acquisition of new customers. The increased credibility associated with AAVLD Accreditation leads to advantages such as:

- Decreased operating expenses from retesting.
- Enhanced management control through management review participation.
- Reduced product liability risk resulting from robust QMS.
- Increased customer satisfaction as a result of customer focused QMS.
- Increased marketability from the commitment to meeting internationally accepted quality standards.
- Participation in funded national and international programs for foreign animal disease detection, animal/zoonotic/and emerging disease surveillance, and export testing.
- Expanding customer ability to reach international markets.
- · Ability to provide documentary evidence (records) of the whole laboratory test process.



Frequently Asked Questions Regarding AAVLD Membership:

When are my dues fee due?

They are due November 15 for the next calendar year. Many members pay for the next year when they register for the annual meeting. Lead time is needed to finalize committee appointments for the new year.

Does it matter who pays for my dues?

No. Your status will be the same with their resepective privileges whether you pay, your employer pays, or your Uncle Vinny.

Are Lab Accreditation dues different than Institutional/Agency membership dues? Yes

- Laboratory Accreditation dues are different and separate and are related to accreditation only and go to fund the accreditation program only.
- · Whether accredited or not, a Laboratory (or Institution/Agency) may additionally become an Institutional/Agency Member. By doing so they are supporting the broad mission of the AAVLD and these funds go to support CE and training and all other activities of the AAVLD. Institutional/Agency Members are highly valued members and are demonstrating leadership and belief in our organizational purpose.

Do Institutional/Agency Member labs have to pay for their employees individual dues? No. A laboratory, institution, agency or department can become a member under this category even without signing up their employees. They are simply supporting the AAVLD mission with their dues payment. Some states are not allowed to pay for employee dues; and some states have budgetary restrictions.
