#### ANNOUNCEMENT AND CALL FOR CASES FOR AAVLD DIAGNOSTIC PATHOLOGY SLIDE SEMINAR

AAVLD Annual Meeting Diagnostic Pathology Slide Seminar Saturday, October 19, 2013, San Diego, California, 3:30-6:00 pm Submission Deadline: July 1, 2013

Anatomic and clinical pathologists are invited to submit cases for the Diagnostic Pathology Slide Seminar at the 2013 AAVLD meeting. Necropsy, surgical pathology, or cytology cases that are challenging or emerging disease entities are solicited. Graduate students and residents are encouraged to present.

Presentations are 5 minutes in length, with another 3 minutes for discussion. Abstracts should be submitted electronically to Dr. Marcia Ilha by July 1, 2013. Cases are reviewed as submitted; case submission will close early if presentation slots (16) are filled.

Style and format: Only one page per abstract please. Please use one inch margins, Times New Roman 11 pt font, center and bold title, center authors (full first name and last name) and affiliations below the title, bold presenter's name. Examples are available via the 2010-2012 slide sessions abstracts posted on the annual meeting page. Presenters of accepted abstracts must supply a set of 65 H&E glass slides for necropsy and surgical pathology cases. Cytology cases should consist of as many glass slides as are available and if less than 65 slides then a series of high quality digital images that are representative of the case. The slide materials should be submitted to Dr. Tim Cushing by September 1, 2013 to allow for distribution and review of slides by attendees before the meeting. Presenters are entitled to a set of slides. The additional slide sets will be available, on a first come-first serve basis, for a \$50 donation to the Pathology travel fund of the AAVLD Foundation. A few slide sets from 2010, 2011, and 2012 conferences are still available for purchase. Please contact Dr. Marcia Ilha if you are interested.

To reduce the chances of delays or file incompatibility, presenters will need to provide in advance (at least one hour before the beginning of the session) the Power Point fileof the presentation as indicated in the Annual Meeting web page for oral presentations. A flash

drive will be available at the AAVLD meeting front desk. Indicate that your presentation is for the Diagnostic Pathology Slide Seminar. Please label your file with the case number (to be provided when your case is accepted) followed by your last and first names (e.g., 8 SMITH Joe). AGENCY: Animal and Plant Health Inspection Service, USDA. ACTION: Notice of availability and request for comments.

<u>SUMMARY</u>: We are advising the public that the Animal and Plant Health Inspection Service is making available a concept paper that describes a revised structure for the National Animal Health Laboratory Network (NAHLN) for public review and comment. The NAHLN is a nationally coordinated network and partnership of Federal, State, and university-associated animal health laboratories working to protect animal and public health and the nation's food supply by providing diagnostic testing aimed at detecting biological threats to the nation's food animals. The concept paper we are making available for comment presents a structure we believe will give the NAHLN increased capacity and flexibility to detect and respond to emerging and zoonotic diseases.

# Porcine Epidemic Diarrhea Virus Identified in the U.S. for the First Time

AAVLD Members:

The following has been summarized from the Iowa Pork Industry Center:

**Porcine Epidemic Diarrhea Virus (PEDV)** has been confirmed in the U.S. for the first time on May 17, 2013.

PEDV is a coronavirus related to transmissible gastroenteritis virus (TGEV) and causes enteric disease clinically indistinguishable from TGE. PEDV was first diagnosed in 1971 in Great Britain. Since that time there have been sporadic outbreaks in Europe and it has become an endemic pig disease in Asia since 1982. PED is not a World Organization for Animal Health (OIE) reportable disease and as such should not affect export markets.

The primary clinical sign in outbreaks that occur in previously naïve herds is severe diarrhea in pigs of all ages. Clinical signs will be essentially identical to those expected with acute TGEV infection. The virus is spread via the fecal-oral route. The most common sources of infected feces are pigs, trucks, boots, clothing, or other fomites. Once infected, the incubation period is very short (12-24 hours) and the virus is shed for 7-10 days. Mortality rate in suckling and early weaned pigs in a naïve herd can be in the 30-100% range.

PED only infects pigs. There are no other known hosts for this virus. It poses no known public health threat.

Veterinarians should contact a veterinary diagnostic laboratory to determine what samples are preferred for that laboratory.

National Veterinary Services Laboratories (NVSL) will accept submissions for PEDV PCR testing that have been worked up in submitting labs initially for differential diagnoses such as TGE and rotavirus and have a strong suspicion for PED. NVSL will not be performing any differential testing on PEDV submissions. Samples will be tested on our in-house nested PCR and reported as positive or negative. NVSL will be performing sequencing and/or virus isolation on selected samples. Laboratories if interested in the NVSL nested PCR procedure can contact beverly.j.schmitt@aphis.usda.gov.

# GAO tells USDA to design strategy for new animal disease surveillance

WASHINGTON, May 22, 2013- The U.S. Department of Agriculture's new methods for surveying animal health need to be fine-tuned to include more informative action plans, according to new Government Accountability Office (GAO) report released Tuesday. The Animal and Plant Health Inspection Service (APHIS) began shifting its disease-bydisease surveillance approach in 2012 to one that monitors the overall health of livestock and poultry. The new approach is designed to improve its ability to analyze health information about production animals.

"USDA is updating its animal disease surveillance efforts to create a national picture of health of the country's livestock and poultry," said director in GAO's natural resources and environment team, Daniel Garcia-Diaz. "In the past it only monitored specific diseases."

In addition to its role as the leading agency for detecting, controlling and eradicating animal disease, USDA must work with the Department of Homeland Security, which is responsible for coordinating all bio-surveillance efforts.
