## **AAVLD PRESIDENT'S MESSAGE**



## Our journal is going electronic

I don't know about you, but I no longer have time to go to my institution's libraries. Actually, that's not quite true. On wet Saturdays, when I have only 10 undone things rather than the usual >30, I sometimes give myself permission to cruise the library stacks and see what

I've missed during the past 6 - 12 months. But for the most part, if I can't get it from my computer at home or in my office, the journal is unread. Time was, cruising the stacks for an afternoon was regarded as part of the job of being an academic or a diagnostician. No longer.

For the past few years the Journal of Veterinary Diagnostic Investigation (JVDI) has been primarily available as a hard copy. It is available electronically, but only sort of. Members of AAVLD can go to the website and access the portable document format versions (pdf) of each issue, and download what they need from http://www.aavld.org/aavld-3/jvdi.jsp. But this is a time-consuming, funky process. The searchable features that exist with online ASM and ACVP journals are lacking. This was one of Dr. Saliki's two major goals when he agreed to take on responsibility as editor for the journal. One is in place, the use of on-line reviewing of submitted manuscripts, since it cuts down time-to-publication.

In advance of its February 2006 meeting, the Executive requested that Dr. Saliki submit a proposal for getting the journal published on-line. Dr. Saliki submitted two proposals: a cheaper one, in which the journal would be available to subscribers as a pdf format only (similar to JAVMA), or a higher cost proposal in which the journal would be available in both HTML and pdf format (similar to Veterinary Pathology, ASM journals and New England Journal of Medicine). The costs of the latter would be \$27,000 for one-time development (including \$2,000 to load back issues), and \$19,800 in recurring annual costs.

We decided to go with the BMW, not the Ford. It has several advantages. Searchability is better, HTML documents open faster than pdf, figures and tables can be seen in expanded versions, and citations can be hotlinked to PubMed abstracts and full-text articles when available. The web publisher will be HighWire Press. This initiative will go a long way towards enhancing JVDI's visibility, the frequency with which good articles are cited, and attractiveness to potential advertisers.

Our electronic publisher, HighWire, is a division of the Stanford University's library system. It produces the online versions of high-impact, peer-reviewed including Science, JAMA, PNAS and NEJM. Some 73 of the 200 most

frequently cited science journals are put out by HighWire. It has progressive policies about encouraging free access to back issues (6 months to 2 years and older; http:// highwire.stanford.edu/lists/freeart.dtl), as well as free access for readers in underdeveloped/post-colonial/ occupied countries. Not least of all, it is the most effective counterweight to predatory private publishers like Elsevier, which are largely responsible for the 8 - 12% annual 'inflation' rate of scientific journals that continue to bleed academic libraries and cause recurrent serial cancellations. As a former head of my institution's library council when we had to agree to several distressing serial murders, I long ago decided that the only way to combat this trend is through professional societies, like ours, working with not-for-profit electronic publishers.

Dr. Saliki anticipates we will have the journal online by the January 2007 issue. In many ways, the JVDI is the most important product of our association, apart from the annual meeting. It is not cheap. In 2005 the journal generated \$44,000 in income from page charges and \$147,000 in total costs, the biggest chunk of which was \$99,000 for printing. Expensive, yet a good investment. Dr. Saliki has been effective in attracting new advertisers, such as Ambion and IDEXX, to help defray publication costs. He is doing exactly what the executive council wanted of him when he came on-board as editor: position our most expensive, visible product to compete with other journals, and ensure that the peer-reviewed work of diagnosticians is shared with the wider scientific community.

At the annual meeting this fall I will propose an increase in membership fees to help defray the costs of going online with JVDI, as well as other changes that the Executive board agreed to at its February meeting. These include hiring a professional meeting organizer, a survey of AAVLD laboratories to see where the manpower shortages are now and where they can be anticipated, and utilizing a private company (MemberClicks) to manage membership payments and the AAVLD web site. We are negotiating with MemberClicks to provide secure credit card payments for members, perform surveys and voting, and maintain self-updated member profiles.

We have not had a fees increase for 5 years. It's time - a good investment for a good organization.

**1.** President Donal O'Toole called the meeting to order at 1:05 p.m.

- **2. APPROVAL OF MINUTES:** A motion to accept the minutes of the November 4, 2005 Executive Board meeting was made (Steffen) and seconded (Layton), and carried unanimously.

Dr. Ardans reported that as of February 17, 2006 AAVLD has approximately \$131,000 in cash on hand. He reviewed activity of the association's mutual funds and major income/expense items from annual meeting and noted that in March 2005 \$180,000 was invested in mutual funds and CDs upon approval by the board. In regard to the unusually high cost of the President's reception in Hershey, Dr. Ardans reported that the food order had to be doubled due to the large turnout for the reception and Foundation auction. The issue of reception admission was raised. The net income for the meeting was approximately the same as the previous year. Dr. Ardans pointed out that although the total membership of USAHA and AAVLD are about same, quite a few less AAVLD members are attending the annual meeting than USAHA members and suggested that this issue be given consideration. The Treasurer's report was accepted as presented.

## 4. PRESIDENT'S REPORT

Donal O'Toole reported that the Government Relations meeting in Washington DC was held February 14-16. On Tuesday evening the group met with USAHA and discussed USAHA's executive director position and the possibility of AAVLD contracting services with this person, trading sponsorship lists including which association will be able to contact each sponsor, and the possibility of exhibitors during the USAHA portion of the meeting.

Meeting site selection and USAHA member attendance at the AAVLD President's reception were also discussed, although no changes were made. AVMA arranged meetings in its new DC offices and following an orientation by the AVMA staff, the first morning was spent with the Animal Ag Coalition, led by John Adams, National Milk Producers. Discussions included USDA budget (\$7 billion decrease) and the redirection of \$5.7 billion to the Ag Defense Initiative. Needs for the NAHLN were reviewed and suggestions made for funding opportunities. \$2.3 million has been committed to plan for Plum Island retention/relocation; however the facility at the island is expected to be in place for at least 10 years. In meetings with the AVMA staff the emphasis was on the Veterinary Workforce Expansion Act (VWEA). Materials, with a focus on the VWEA and to a lesser extent on the NAHLN, were provided for visits with state congressional representatives.

Wednesday meetings were held in Riverdale on National Animal Health Policy and Programs. Thursday meetings were held in the Whitten Building with Drs. Ron DeHaven and John Clifford both of whom pledged support for the NAHLN expansion and maintenance.

A letter was sent to NVSL proposing a mock AAVLD site visit. Proposed members of the site visit team are Grant Maxie, Terry McElwain and Leon Thacker. The NAHLN Steering Committee met in January and discussed the British Columbia/Washington State avian influenza exercise, five state exercise, data and messaging standards, Luminex multiplex assay, BSL-3 space, and the best use of remaining funds in the NAHLN budget. The use of NAHLN funds will be further discussed at the next meeting. Samples for H5 N1 testing for Wildlife Services and the National Wildlife Research Center will be processed through NAHLN laboratories. John Clifford was approached regarding AAVLD input in selection of candidate for NVSL director and as a result Dr. O'Toole has been asked to serve on the interview panel for the position. A candidate has been identified to replace Donna Dare in the exhibit coordinator position. The person hired will be paid a commission for each exhibitor obtained in addition to the normal honorarium.

Dr. O'Toole proposed AAVLD do a survey of laboratory directors similar to the survey done by ACVP regarding manpower needs in veterinary diagnostics.

## 5. COMMITTEE REPORTS

#### A. Accreditation

Leon Thacker reported that the Accreditation Committee met from 8:00 AM – 12:00 noon on February 21, 2006 and all members were in attendance, including the newest member, Helen Acland, and resigning member, Don Lein. The finances of the Accreditation committee are solvent. The committee reviewed the current accreditation fees which are as follows: \$300.00 annual laboratory dues, \$500.00 site visit fee and \$300.00 per branch laboratory visit fee. Site visit reports were received for the Oregon Veterinary Diagnostic Laboratory and Ohio Animal Disease Diagnostic Laboratory. A draft test validation document was reviewed. The committee also reviewed and approved a document "Definitions and Review Procedures for Various Laboratory Administrative Structures". In addition the committee accepted site visit guidelines to be used internally by Accreditation committee.

## B. Program

Barb Powers reported that the program committee membership has been updated. Proposed Joint Plenary Session topics include surveillance issue (e.g. global avian influenza, zoonotic diseases & public health, domestic animal surveillance & NAHLN, food surveillance & FERN, gaps in the current surveillance system). Dr. Powers requested that any comments or suggestions regarding topics or speakers be emailed to her. No specific topics have yet been chosen for the AAVLD scientific sessions. John Andrews will be giving a presentation on the state of diagnostic laboratories and issues facing them.

Proposals for workshops including budgets were received as follows:

- · CL Davis avian pathology symposium
- · NAHLN emergency response symposium with a half-day QA breakout session in the afternoon A motion (Maxie, Spinato second) to approve the CL Davis and NAHLN workshops carried unanimously.

A proposal was also received from the Epidemiology Committee for a sampling workshop. A budget was received and expenses will be covered by registration fees & sponsorships. Dr. Powers noted that the sponsorships for this workshop presents another conflict within the association for solicitation of

sponsorships and highlights the need for a more streamlined and coordinated sponsorship policy. A motion (Maxie, Layton second) to approve the Epidemiology sampling workshop carried unanimously.

A website for electronic abstract submission will be instituted this year and will be linked to the AAVLD website. It is hoped that the electronic submission will streamline the abstract review process.

- C. Canada Report Dr. Shane Renwick presented the report as follows:
- 1. New Prime Minister and Minister of Agriculture and Agri-Food

A general election was held in Canada on January 23, 2006. The Conservative party headed by Stephen Harper has formed a minority government and replaced the Liberal Party headed by former Prime Minster Paul Martin. The new government has particular strength in Western Canada and in rural Canada in general, having elected few members from large urban centres such as Toronto and Montreal. Mr Chuck Strahl, a businessman from British Columbia, has replaced Andy Mitchell as Minister of Agriculture and Agri-Food.

#### 2. Avian Influenza

In August 2005, a national survey of migratory waterfowl was initiated by the Canadian Cooperative Wildlife Health Centre (CCWHC) with support from Environment Canada, the provinces, the Canadian Food Inspection Agency (CFIA) and the Public Health Agency of Canada. The national survey includes samples from migratory birds along six flyways. Testing (RRT-PCR) was conducted in six provincial and university veterinary diagnostic laboratories belonging to the CAHSN network with QA oversight, confirmatory testing and molecular typing provided by the CFIA Winnipeg laboratory. All of the AI viruses identified were confirmed to be low pathogenic, North American strains. Nationally, over 3800 samples (cloacal swabs) were collected with about 40% positive for influenza A and about 5.5% positive for H5. Monitoring of dead birds will be expanded in 2006. Another survey of live birds is planned and final details are currently being worked out.

#### 3. BSE

On January 23, 2006 the CFIA confirmed bovine spongiform encephalopathy (BSE) in an approximately six-year-old cross-bred cow born and raised in Alberta. No part of the animal entered the human food or animal feed systems. This finding was not unexpected and was identified through Canada's national surveillance program, which targets cattle at highest risk of being infected with BSE. To date the program has tested more than 90,000 animals since Canada's first BSE case in 2003. Over 7,500 animals have been tested so far during 2006. The CFIA's animal investigation is complete. A total of 156 cattle from the affected animal's birth cohort were identified and traced. All animals were accounted for and no additional cases of BSE were detected. As of February 17, the feed investigation was nearing conclusion. A final analysis of records collected at the farm, retail and mill levels is underway. In keeping with previous findings of BSE in Canada, the CFIA will prepare and distribute a full report on the epidemiological investigation.

## 4. Canadian Animal Health Surveillance Network (CAHSN)

This project is led by the Canadian Food Inspection Agency (CFIA) and involves a partnership with the Public Health Agency of Canada (PHAC), provincial and university veterinary diagnostic laboratories. The principle objective of the CAHSN is to develop early detection capability for key high threat diseases (FMD, END, CSF and AI). An important tool to be used by the CAHSN will be web based software developed by PHAC to support the Canadian Public Health Intelligence Network (CPHIN). As an initial pilot study to test the system, laboratories in the TSE Diagnostic network are linked through a common reporting database to provide up to date national reporting of BSE surveillance test data. Under the project, some equipment (RT-PCR) has been purchased for installation in network diagnostic laboratories. CFIA Quality Assurance and Biocontainment experts are planning site visits to all CAHSN laboratories over the next few months to assess individual laboratories and make recommendations on what, if any, investments need to be made.

## 5. Canadian Animal Health Laboratorians Network (CAHLN) Meeting 2006

The CAHLN Annual Meeting will be held June 4-7, 2006 in Ottawa. Keynote speakers include: Dr. Brian Evans, Chief Veterinary Officer of Canada on the new Canadian Animal Health Strategy; Dr. Barb Powers, of the American Association of Veterinary Laboratory Diagnosticians (AAVLD) on developments with the US National Animal Health Laboratory Network; Dr. Paul Kitching on the Canadian Animal Health Surveillance Network

(CAHSN), Dr. Jane Parmley of the BC Centre for Coastal Health on Avian Influenza; Dr. Neil Cashman of PrioNet Canada on prion research; Dr. Sharon McGladdery, of Department of Fisheries and Oceans on the laboratories' role in the new National Aquatic Animal Health program. Over 35 technical presentations are expected with presentation of awards for Canadian Laboratorian of the Year and Best Presentation by a Graduate Student. This year's meeting will be combined with the annual meeting of the Canadian Association of Veterinary Pathologists.

## 6. New Veterinary School at the University of Calgary

The new veterinary medical school at the University of Calgary is scheduled to open in September 2007. The three-year program will focus on production animal medicine of all species, population medicine and epidemiology. It will be closely linked with the university's Faculty of Medicine and is expected to graduate 30 veterinarians each year. There will be close cooperation with private veterinary clinics in developing clinical programs. The program will coordinate with other provincial animal-medicine programs in universities and colleges throughout the province. It will also complement the Western College of Veterinary Medicine (WCVM) in Saskatoon. A steering committee will be established to develop a program that will meet the province's rural practitioner and research needs.

## 7. New Alberta Prion Research Institute

The Alberta Prion Research Institute officially opened on February 2, 2006. The Institute is a \$35 million initiative announced by the Government of Alberta in February 2005 that supports top researchers committed to finding an Alberta-based solution to the serious issues and challenges associated with prions. The Institute will coordinate fundamental, applied and multidisciplinary research geared toward providing solutions and models of policy action that can meet the BSE challenge for the beef and food industries, and similar challenges from other transmissible spongiform encephalopathies and other diseases in plants, animals and humans related to protein misfolding. The Prion Institute takes an Alberta-wide approach to prion-related research, incorporating a research strategy that engages a broad spectrum of disciplines to address economic and social impacts of prion and related diseases. It will support outcomes-oriented research on prevention, mitigation and treatment of these diseases, and will develop the scientific evidence to inform public policy on solutions and best practices.

## D. Membership Report:

Grant Maxie reported that membership numbers are stable. The new member welcome in Hershey, PA was successful and will be continued at the 2006 Annual Meeting. Timing of the meeting may be adjusted to allow for an USAHA representative to attend. The membership committee meeting will be moved to different time to avoid conflicts with other meetings that the Vice-president must attend.

Richard Mock reported that the Life Member list in the AAVLD directory includes some deceased members. He proposed that these members be moved to a 'Role of Honor'. The board agreed and the issue will be forwarded to the House of Delegates for inclusion in the Bylaws.

## E. Foundation:

Barb Powers reported that Paige Carmichael is now the chair of the committee. The Foundation will again hold an auction at the Annual Meeting which will also include a silent auction portion. The new exhibit coordinator will be approached about helping with the auction.

There was a discussion regarding possible changes to the AAVLD President's reception. It was agreed that the bar would be changed to full cash bar. USAHA will be requested to provide AAVLD with a portion of registration fees to help cover the reception and a donation from each region of USAHA for the auction.

## F. NVSL

Bev Schmitt reported that follow-up on *Brucella ovis* antigen testing is being done and results for 10 out of 16 labs are completed. The core NAHLN laboratories are doing testing for CSF and web-based forms are currently going through user acceptance. A second training session for HL7 messaging is occurring during the week of February 20<sup>th</sup>. Implementation of the incident command structure for high path avian influenza surveillance is underway and approximately \$10M in Wildlife Services money will be going to NAHLN laboratories for testing.

The core quality assurance team is making great strides. NVSL will probably bring in A2LA for accreditation, but a final decision has not yet been made. A response letter was recently sent regarding the AAVLD mock site visit requesting that the visit occur sometime after March, possibly after the new NVSL director is in place. NVLS will look at both the AAVLD and ISO 17025 processes to determine NVSL's direction. Tests for which NVSL will most likely be seeking ISO accreditation will include EIA, Newcastle, avian influenza RT-PCR, vesicular stomatitis, TSE IHC, foot & mouth and equine piroplasmosis ELISA.

## G. Nomination

Gary Osweiler reported that the committee has been selected and consists of Gene Erickson, Flint Taylor and Sharon Hietala. The Nominations committee has responsibility for selecting new officers (Vice President), and when necessary Secretary-Treasurer. Osweiler reported for information purposes that the three regions up for elections are the Northwest, Southwest and Canada (Provincial). All current representatives for these regions are eligible to run for a second term. The responsibility for regional representative elections falls to a committee appointed by the President for each region as defined in AAVLD By-Laws Article V, Section 2.

Alex Ardans reported that the Secretary/Treasurer's position is also up for election this year. Dr. Ardans is not interested in running for another three year term, but is willing to stay on for another year to assist with the transition. The Board agreed that they would like Dr. Ardans to stay on for an extra year.

#### H. Awards:

Gary Osweiler reported that the Awards committee has been set according to the Bylaws.

Donal O'Toole reported that the money from auction will be used to match one travel award per committee provided the committee can raise the matching funds (\$500). Dr. O'Toole also reported that he would like to recognize Donna Dare for her service to the association with a formal thank-you. An award will be presented as a special tribute from the President and will include a plaque and gift. A travel voucher was suggested and Dr. Harvey Gosser will be contacted for additional ideas. A motion to commit \$1000 from the Association's general fund for the award was made (O'Toole), seconded (Steffen) and carried unanimously.

## I. Miscellaneous Reports

Alfonso Torres reported that the Northeast region recently held a 1-day session at the USAHA Northeastern regional meeting to discuss regional AAVLD issues. He also reported that funding in the amount of \$80M has been secured for New York's new laboratory building. Once the funding is official Dr. Torres will be sending a letter to the Accreditation Committee.

### 6. OLD BUSINESS

## A. Veterinary Workforce Expansion Act

Donal O'Toole reported that AVMA has requested letters of support for the Veterinary Workforce Expansion Act. Those willing to support this act should write a letter in their capacity as a laboratory director.

## B. NAHLN Steering Committee Update

Bev Schmitt reported that hiring certificates have been completed for the assistant and associate positions and are now awaiting approval. Dr. O'Toole reported that the draft NAHLN Strategic plan and draft requirements for becoming a NAHLN laboratory will be sent out to the Board.

Barb Powers noted that the "Definitions and Review Procedures for Various Laboratory Administrative Structures" document approved at the Accreditation Committee, once finalized, may be helpful for the NAHLN guidelines. She also noted that some non-AAVLD laboratories that are currently in NAHLN, such as poultry laboratories that are full service, should be informed that they can apply for accreditation.

Donal O'Toole reported that Homeland Security may be willing to contribute money to the NAHLN, but will require more than the White Paper for funding. Homeland Security would need to see a report of what increased testing service would result from the funding. If approved by USDA, Dr. O'Toole requested that anyone willing to work on developing this document contact him. The issue will also be added as an agenda item for the next

NAHLN Steering Committee meeting. Increased funding is needed in order to make the NAHLN fully functional. Congressional representatives with whom the AAVLD delegation met with in Washington DC were not very aware of NAHLN. AAVLD needs to work to move up the NAHLN on the AVMA priority list by contacting individual AVMA representatives. AVMA support for the NAHLN will be voted on at next AVMA Executive meeting. It was suggested that the NAHLN map be adjusted to show funded NAHLN labs.

## C. Summer Meeting Location

Alex Ardans distributed a list of possible hotels and rates in the San Francisco Airport area for the summer meeting. The Executive Board meeting will be held Thursday, July 13th, 8AM-12 noon. The Accreditation Committee will meet Thursday, July 13th, 1-5PM and Friday, July 14th, 8AM-12 noon.

A motion (Maxie, Powers second) to meet at the Holiday Inn Express San Francisco Airport North carried unanimously.

## D. Survey on Workforce Shortages.

Donal O'Toole reported that two quotes for the survey were obtained. The estimated cost is \$8,500.00. The survey will be web-based and laboratory directors will be requested to participate. The survey company will collect the information and compile a report. Dr. O'Toole hopes the resulting report will be similar to the AVMC report documenting shortages. Recommendations from the survey companies included keeping questions short and to the point and limiting the survey to 25 questions. Dr. O'Toole read a sampling of the proposed survey questions. Participants will be asked to designate their AAVLD region at beginning of survey. There was discussion regarding increasing the number of questions related to training included on the survey and soliciting donations from participating laboratories to help cover the cost of the survey.

A motion (O'Toole, Spinato second) to work with Survey Research Laboratory, University of Illinois at Chicago to start the survey process carried with one abstention.

## E. Electronic Journal Publishing

A written proposal to publish JVDI online was submitted by Jerry Saliki. The proposal is to use HighWire Press to publish the journal electronically, which will cost approximately \$25,000.00 in start up fees and \$15,000 in recurring fees. Alex Ardans reported that in 2005 the journal had approximately \$44,000 in page charge income and \$147,000.00 in total costs including \$99,000.00 in printing costs. He suggested that advertisements were a possibility for increased journal revenue. There was discussion regarding the benefits and costs of publishing the journal electronically and possible increase in membership fees.

A motion (O'Toole, Powers second) to approve electronic publishing using HighWire Press carried unanimously. The Secretary/Treasurer's office will present a proposal for a membership/subscription fee increase at the July meeting, Alex Ardans asked the Board to consider what the association's long term plans are for the association's resources and suggested that the Strategic Planning and Financial Advisory Committees be asked to consider the issue.

### 7. NEW BUSINESS:

## A. Role of Meeting Coordinator

Donal O'Toole reported that Jackie Casserly has been selected as the new AAVLD meeting coordinator. She owns her own meeting planning company, Planning Connection, in Gainesville, Florida and plans meetings for several other organizations. She will initially be hired for a one-year overlap with Donna Dare to facilitate the transition. Before December 2006 she will submit a formal set of recommendations for the meeting's development and management. She will receive a \$5,000.00 base salary and 15% commission on exhibitor fees and sponsorships collected in excess a set amount and will attend the meeting site visit in April. Casserly was introduced to the Board via teleconference and she discussed her firm's operations. Additional roles she will be asked to assume will be helping with the Foundation auction and soliciting meeting sponsors.

## B. Online Membership Management:

Alex Ardans presented a proposal for online membership management. The proposed membership management program, MemberClicks, will allow the association to collect secure credit card payments, perform surveys and voting, maintain self-updated member profiles, post events and collect registration all online in addition to webpage management capabilities and more. A motion (Wilson, Maxie second) to allocate the necessary funds to purchase MemberClicks, to be reevaluated in one-year, carried unanimously.

## C. Grandfathering Test

Sharon Hietala presented a document, developed by a small work-group, containing guidelines for grandfathering existing test methods. It provides categories of acceptable criteria for existing tests. The Accreditation committee requested that the list of reputable technical organizations be distributed to the discipline committees for feedback on additional organizations that should be added to the list. Suggestions are due by July, when the Accreditation Committee will again review the document. Donal O'Toole will contact the chair of each discipline committee to request that they submit a list of published reputable technical manuals with methodologies used. Sharon Hietala will help to compose the note. The document will be taken on by the Accreditation Committee after feedback is received and after the October meeting it will be made available to the membership. The document will serve as a starting point for existing methods and the Approved Methods committee is still charged with developing validation guidelines.

## D. Annual Meeting Registration Fee Increase

USAHA has requested to increase meeting registration fees by \$25.00. A motion (O'Toole, Powers second) to increase annual meeting registration fees carried unanimously.

## E. Relationship between QA and Accreditation Committees

The Accreditation Committee recommended formation of QA committee several years ago. The QA Committee was charged with creating a quality manual template. It has now grown to be a large committee and they would like to clarify the role of the QA Committee in relation to Accreditation Committee. Leon Thacker noted that the Accreditation Committee is currently undergoing many changes and is not yet sure how it will draw on the QA Committee's resources. This year there will be a QA member on site visits for the first time. It was determined that the QA Committee should remain a special committee similar to the other discipline committees and that a clear mission should be developed.

## F. Donation Matching for Beth Williams Memorial

Donal O'Toole reported that he had been approached to have AAVLD match a \$500.00 donation given by USAHA to the Beth Williams/Tom Thorne Memorial fund. It was suggested that the money should come out of the Foundation fund. Barb Powers will contact the Foundation chair, Paige Carmichael to inquire.

## G. USAHA Executive Director

USAHA has invited AAVLD to share the Executive Director they plan to hire. USAHA expects to pay \$110,000.00-120,000.00 in salary and benefits plus \$10,000.00 for travel expenses for the Executive Director. Proposed functions that the Executive Director could perform for AAVLD are:

- -Organize national meeting
- -Website management, membership management
- -Other roles within organization

The person will not be allowed to lobby and will probably not be located in Washington DC because violating the organization's apolitical status will result in a loss of tax status.

Barb Powers suggested that the position could be used to track government activities, coordinate resolutions and compliment the role of Jackie Casserly, overseeing issues in bringing the two organizations together. Concern was expressed by several members that it would be difficult for the person to serve two organizations equally. It was suggested that AAVLD carefully assess the need for this position.

USAHA is willing to develop legal agreement allowing AAVLD to withdraw from the arrangement. Dr. O'Toole will contact Brett Marsh and ask for the Executive Director's job description. After circulation of the job description further discussion will be held regarding the possibility of using the Executive Director's services.

## **AAVLD Internal Bacteriology Quality Assurance Survey 2006**

This year, the survey includes five organisms and case histories contributed by members of the IBQAS Committee. The National Veterinary Services Laboratories is providing support to compile and ship the survey kits to participants in early June. More detailed instructions will be included with the check test.
